

Security Code of Ethics

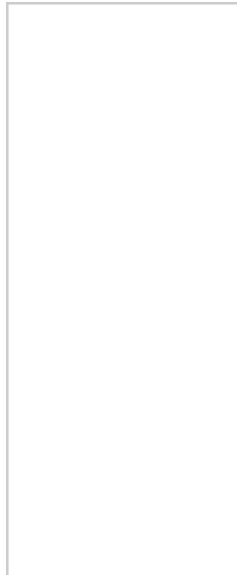
- Conduct business and ensure that all employees perform in a manner which increases public trust and confidence.
